NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of Palisade Park North Metropolitan District No. 1 shall and hereby does amend the budget for the fiscal year 2023 as follows:

Debt Service Fund\$ 480,000Capital Projects Fund\$1,859,392

BE IT FURTHER RESOLVED, that such sums are hereby appropriated from unexpected revenues available to the District to the Debt Service Fund and Capital Projects Fund for the purposes stated.
